## State of the Net – Feb 11 2025

## Keynote Speaker: Hon. Beth Williams

- **Introduction by Steve DelBianco:** He introduced Beth Williams and welcomed her to the State of the Net 2025 event.
- Opening Remarks by Beth Williams:
  - Expressed gratitude for the invitation.
  - Introduced the Privacy and Civil Liberties Oversight Board (PCLOB) and its mission to balance counterterrorism efforts with privacy and civil liberties.
  - Mentioned that despite being **sub-quorum**, the PCLOB is still active and has adopted a **new policy** to ensure work continues.

## Key Points from Beth Williams' Speech

- 1. PCLOB's Sub-Quorum Policy:
  - The **new policy (adopted in October)** allows operations to continue even with only one member.
  - Enables staff to conduct investigations, issue reports, and provide recommendations.
  - Allows interaction with executive agencies, Congress, and other stakeholders.
- 2. Current and Future Projects:

#### • EO 14086 & U.S.-EU Data Privacy Framework:

- PCLOB reviewed Intelligence Agencies' Attorney General Guidelines.
- Participated in the first U.S.-EU review of the framework.
- Ongoing analysis of policy implementation and redress mechanisms.

#### • Domestic Terrorism & Free Speech:

- Investigating how counter-disinformation efforts affect free speech.
- Examining whether these efforts **disproportionately impact specific groups**.
- Expressed concern over **government pressure on social media companies**.
- Facial Recognition in Aviation Security:
  - Evaluating the benefits vs. civil liberties risks of facial recognition in airports.
- FISA Section 702 Reforms:
  - Discussed past PCLOB reports on **FBI abuses** of FISA.
  - Advocated **new safeguards** to prevent misuse.
  - Anticipating reauthorization in **spring 2025**.
- Potential Future Investigations:
  - Examining **government influence over banks ("debanking")** in counterterrorism cases.
  - Investigating government access to financial data, including the SEC's Consolidated Audit Trail.

#### 3. Commitment to Independent Oversight:

- Emphasized **rigorous**, evidence-based oversight.
- Rejected **partisan influence**, citing historical examples of single-member leadership.
- Asserted that PCLOB remains **"open for business"** despite the lack of a quorum.

## **Q&A** Session

- 1. **Steve DelBianco:** Asked about **preventing government pressure** ("jawboning") on content platforms.
  - Williams responded that **PCLOB can help provide transparency** and recommend guardrails to prevent abuse.
  - Noted that **Congress is already considering legislation** on this issue.
- 2. Jake Laperruque (Center for Democracy & Technology): Asked if PCLOB's independence is compromised by the president's ability to fire members at will.
  - Williams avoided direct criticism of the administration.
  - Stated that **PCLOB's statute does not provide for-cause protections**.
  - $\circ$   $\;$  Reiterated focus on ensuring the board continues functioning.

- Encouraged continued engagement and transparency.
